Part of this project closeout requires an easement to be granted to Beaufort Jasper Water and Sewer Authority (BJWSA) for maintenance purposes. An ordinance has been prepared for the next Public Facilities Committee;
- ❖ Public Works is going to assist with Airfield Maintenance;

- ❖ COVID-19: Mr. Rembold briefed the board members on the 3 airlines' commitment:
  - to deliver a new standard of clean environment for customers
  - to provide masks and require them to be worn on flights
  - to offer sanitizing wipes or gels for passengers as well.
- ❖ TSA updates: TSA has implemented changes to the security screening process that reduce the potential for cross-contamination at the security checkpoint in an effort to help prevent the spread of COVID-19. Also, TSA officers at checkpoints are now using facial protection. Travelers are encouraged to wear face protection to the checkpoint as well.
