STATE OF SOUTH CAROLINA COUNTY OF JASPER

ORDINANCE: # 08-15

AN ORDINANCE OF JASPER COUNTY COUNCIL.

To make certain findings and determinations; to adopt certain definitions; to prohibit the wearing of certain attire; to provide for enforcement, violations and penalties; and provide for a public education program.

BE IT ORDAINED by the Jusper County Council in council duly assembled and by the authority of the same:

FINDINGS AND DETERMINATIONS.

- A Jesper County, South Carolina (the "County") is a county organized and existing under the lews of the State of South Carolina and as such, possesses all the powers granted in counties by the Constitution and the lews of the State of South Carolina, including the powers enumerated in the Code of Laws of South Camilina §4-9-25 and §4-9-30(1976 as amended) relating to health, security, general welfare, peace, and order within the County.
- B. Jasper County Council is convinced that our community is beginning a period of tapid growth and development. Many aspects of this growth will be good for the economic and social well being of our people; however, one the challenges for Jasper County is to ensure that our civizens are provided with appropriate life skills to allow them to attain the maximum benefit from the opportunities which our County's development will present to them.
- C. To date, Jasper County has not well positioned itself or its citizens to benefit from the kinds of new jobs that are likely to be presented in the community. According to the South Carolina Stastical Abstract, more than one-third of our people are without a high school diploma while less than nine percent have a college degree. Our citizens have a median household income of about thirty dicurand dollars; however, sixuous percent of our families are below the poverty line and even worse, twenty-nine percent of our children live below the poverty line. In conjunction with parents and guardians and the Jusper County School District, the community needs to ensure that all of our young people graduate from high school with good employability skills, strongly developed

work habits, self discipline, the ability to deal cooperatively with other members of the community, a faith in their own abilities and the guidance of their creator, and an abiding sense of self worth.

- D. Jasper County Council recognizes that young people are a product of their environments and therefore it is important that the adults around them demonstrate the many qualities which characterize the best of Jasper County. In short, we believe that adult role models are important examples for the young people to allow a community transfer of necessary life skills.
- E. Parent and guardian have a key role in not only setting examples but in requiring their minor children to adhere to appropriate forms of order and decorum, as a method of developing skills and self discipline.
- F. At the same time we believe that people who have not been taught appropriate life skills will frequently develop traits such as tardiness and sloppy appearance which can have a negative influence on prospective employers.
- G. Jasper County Council believes that at a minimum, the standards of dress set forth below for all persons within the county send important messages to the people of this area and particularly to the young people of Jasper County that their dress is important to the general welfare, health, peace, order and security of the community.
- H. We do not believe that this ordinance is a complete solution to the difficult challenges of preparing our youth and young adults for the twenty-first century but we do believe that it is one step and an important one to demonstrate that we care about them and about their welfare.

DEFINITIONS.

Unless the context shall clearly indicate some other meaning, the terms defined in this section shall for purposes of this ordinance have the meanings herein specified. Definitions shall be equally applicable to both singular and the plural forms of any of the terms herein defined.

"Crest of the itium" means the upper portion of the dorsal, upper and largest area of the three bones composing either laterel half of the pelvis that is broad and expanded above the greater sciatic notch.

"Intimate clothing" means underwear, underpents, slips, girdle, athletic supporter, thougs, or other similar garments ordinarily worn beneath pants.

"Public place" means on area which the public is invited or to which the public is admitted or has access, including but not limited to educational facilities, both public and private, licensed child care and adult day care facilities. healthcare

facilities, hotel and motel lobbies, public transportation facilities, restaurants, retail food production and marketing establishments, retail service establishments, retail stores, shopping malls, theaters, galleries, libraries, museums, convention facilities, conference centers, exhibition halls, stadiums, ball parks, other places of meeting or public assembly, inclusive of lobbies and audience seating areas, roadways, pathways, sidewalks, yards of residential, commercial and governmental buildings or facilities when visible from roadways, common areas in apartment buildings, condominiums, trailer parks, retirement facilities, nursing homes, and other multiple unit residential facilities, restrooms, lobbies, reception areas, hallways, and other common use areas, rooms, chambers, and private clubs when being used for a function to which the general public is invited. A private residence is not a public place unless it is used as a child care, adult daycare, or healtbeare facility.

PROHIBITION OF CERTAIN ATTIRE; DUTIES OF PARENTS AND GUARDIANS.

- A. It shall be prohibited for any person to appear in a public place wearing his or her pants more than three (3) inches below his or her hips (crest of the ilium) and thereby exposing his or her skin or intimate clothing.
- B. It shall be prohibited for any custodial parent or guardian to willfully allow their minor to appear in a public place wearing his or her pants more than three (3) inches below his or her hips (crest of the ilium) and thereby exposing his or her skin or intimate clothing.

ENFORCEMENT.

- A. This ordinance shall be enforced by the Sheriff of Jasper County and his authorized designees, municipal law enforcement officers and by the Jasper County Administrator and his authorized designees.
- B. Any citizen who desires to register a complaint under this ordinance may initiate enforcement with the Sheriff of Jasper County.
- C. Not withstanding any other provision of this ordinance, Jasper County or member of the public may bring a legal action against any person to enforce the provisions of this ordinance.

VIOLATIONS AND PENALTIES.

A. A person who violates a pravision of Section 3 of this ordinance shall be guilty of an infraction, punishable by a fine of not less than twepty-flye (\$25.00) dollars, nor more than five hundred (\$500 00) dollars.

- B. Violation of this ordinance is hereby declared to be a public nuisance, which may be abated by the County by restraining order, preliminary and permanent injunction, or other means provided for by law and the County may take action to recover the cost of the nulsance abatement.
- C. Each day of a continuing violation of this ordinance shall be considered a separate and distinct infraction.

PUBLIC EDUCATION.

The County in conjunction with the Jasper County School District shall engage in a continuing program to encourage and clarify the purposes and requirements of this ordinance and to guide adults and youth in development of critical life skills for improved employability. The County Administrator shall be responsible for the County participation in this program.

EFFECT OF SECTION HEADINGS.

The headings or titles of the several sections hereof shall be solely for the convenience of reference and shall not alter the meaning, construction, interpretation or effect of this ordinance.

SEVERABILITY.

If any provision, clause, sentence, or paragraph of this ordinance or the application thereof to any person or circumstances shall be beld invalid, that invalidity shall not affect the other provisions of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

EFFECTIVE DATE.

This ordinance shall take effect upon approval by council.
