**BACKGROUND:** Beaufort County issued a Request for Proposals (RFP) to solicit proposals from qualified firms to provide wireless cell phone service and equipment. Proposals from three firms, Verizon Wireless, T-Mobile, and Sprint, were received and evaluated by an evaluation selection committee. The evaluation selection committee consisted of Dan Morgan, MIS Director, Theresa Roberts, MIS Telephony Support, Mary Heyward, MIS Computer Tech, and Lieutenant Matt Averill, Beaufort County Sheriff's Office. Oversight of the process was provided by the Purchasing Director. All three vendors were interviewed and their recommended phones were tested for service reliability. In accordance with the RFP selection criteria, Verizon Wireless received the highest ranking by the committee, due to offering the lowest price, record of excellent customer service, overall best cell phone coverage testing results, their emergency preparedness plan, and their implementation plan. The contract includes cellular service for 382 phones and accessories. For more information, please see the attached presentation for a detailed review of the committee's findings.

**RECOMMENDATION:** The Finance Committee approve and recommend to County Council the contract award to Verizon Wireless, the top ranked firm, with the anticipated cost for the first year of \$176,594. Additionally, there are four optional annual renewals to this contract that are subject to County Council for approval. With the four annual renewals, the total anticipated cost for five years is \$882,970.

SUBSTITUTING THE BEAUFORT, PORT ROYAL & SEA ISLANDS VISITOR & CONVENTION BUREAU FOR THE BEAUFORT REGIONAL CHAMBER OF COMMERCE AS THE COUNTY'S DESIGNATED MARKETING ORGANIZATION, AS DEFINED IN SOUTH CAROLINA CODE ANNOTATED SECTION 6-4-10; AUTHORIZING THE BEAUFORT, PORT ROYAL & SEA ISLANDS VISITOR & CONVENTION BUREAU TO MANAGE AND DIRECT THE PORTION OF LOCAL ACCOMMODATIONS TAXES COLLECTED BY THE COUNTY AND PUT IN A SPECIAL FUND FOR THE PROMOTION OF TOURISM; AND OTHER RELATED MATTERS.

WHEREAS, pursuant to South Carolina Code Annotate section 6-4-10 ("Act"), the County is required to allocate thirty percent of the funds collected from local accommodations taxes to a special fund used only for advertising for and the promotion of tourism in the County ("Tourism Fund");

WHEREAS, the County is authorized to identify an organization as the "Designated Marketing Organization" ("DMO") to manage and direct expenditures from the Tourism Fund;

WHEREAS, the Beaufort Regional Chamber of Commerce ("Chamber") serves as the County's DMO and manages and directs expenditures from the County's Tourism Fund;

WHEREAS, the Chamber requests the County to substitute the Beaufort, Port Royal and Sea Islands Visitor & Convention Bureau ("VCB") for the Chamber as the County's DMO;

WHEREAS, the VCB is organized as a nonprofit organization under South Carolina Code and has an existing and ongoing tourism promotion program;

WHEREAS, the Chamber requests the County to allow the Chamber to automatically resume the Chamber's status as the County's DMO if the VCB is unable to meet its responsibilities as the County's DMO.

NOW THEREFORE THE COUNTY COUNCIL OF BEAUFORT COUNTY, SOUTH CAROLINA, RESOLVES:

Section 1. The County finds the VCB meets the requirements of the Act to be designated as the County's DMO.

Section 2. The County substitutes the VCB for the Chamber as the County's DMO and the VCB is authorized to manage and direct expenditures from the Tourism Fund.

<u>Section 3</u>. The Chamber will automatically resume the Chamber's status as the County's DMO if the VCB is unable to meet its responsibilities as the County's DMO.

<u>Section 4</u>. The County Administrator (and his designated appointees) is authorized and directed, in the name of and on behalf of the County, to take whatever further actions, as the County Administrator (and his designated appointees) deems to be necessary and prudent to effect the intent of this Resolution.

Section 5. This Resolution is effective immediately. All other orders, resolutions, and parts of either in conflict with this Resolution are, to the extent of that conflict, repealed.

#### Dear Gary,

This letter serves as a request by the Beaufort Regional Chamber of Commerce ("Chamber") to have the County name the Beaufort, Port Royal & Sea Islands Visitor & Convention Bureau ("VCB") as its designated marketing organization ("DMO"). As the DMO, the VCB would be eligible to manage and receive a portion of the local accommodations tax revenue collected by the County. The Chamber has proudly served as the County's DMO and is confident that the reorganization of the VCB as a separate entity will benefit the County and all the businesses served by both the Chamber and the VCB.

The VCB has been operating as the division of the Chamber and has been responsible for the marketing and tourism programs and efforts of the Chamber. Recently, the Chamber voted to separate the VCB into an independent organization and assign all of the Chamber's tourism and marketing responsibilities to the VCB. The Chamber believes that the VCB, operating as a separate organization, will be able to provide the County with a more focused and efficient tourism and marketing services program.

Because the VCB has taken on all of the Chamber's tourism and marketing responsibilities, the Chamber requests that the County also permit the VCB to take on the Chamber's role as the DMO for the County. This would allow the VCB to receive and manage that portion of the local accommodation taxes collected by the County and allocated for the promotion of tourism. The Chamber has been informed that VCB is a qualifying organization under South Carolina Code Annotated § 6-4-10 and that the VCB is organized with the South Carolina Secretary of State as a nonprofit organization. The Chamber is confident the VCB will continue the Chamber's tourism promotion program while developing additional programs of its own.

The Chamber is offering the VCB its full support and assistance as the VCB establishes itself. The Chamber is confident the VCB will step into the role formerly filled by the Chamber and will meet the tourism promotion needs of the County to include continuing to be a proper steward of the County's tourism fund. However, please note that, that if the VCB is unable to perform its function as the DMO, then the Chamber would be available to once again, be designated as the County's DMO, and thereafter, reestablish its former tourism and marketing programs.



The Chamber is excited about the future of tourism and marketing and knows that the Chamber and VCB will continue to work together to promote Beaufort and the businesses both organizations mutually represent.

#### Re: Designated Marketing Organization

Dear Gary,

This letter serves as a request by the Beaufort, Port Royal & Sea Islands Visitor & Convention Bureau ("VCB") to have County designate the VCB as a marketing organization eligible to manage direct expenditures from the portion of the local accommodations tax revenue collected by the County and designated for the promotion of tourism in the County.

According to South Carolina Code Annotated § 6-4-10, the County is required to allocate thirty percent of the revenues collected from local accommodations taxes to a special fund for advertising and promoting tourism in the County. The County is permitted to designate an organization to manage this special fund – a designated marketing organization. To be eligible for this designation, an organization must 1) be organized as a nonprofit organization and 2) demonstrate to the County that it has an ongoing tourism promotion program. As discussed below, the VCB is an organization that is eligible to be the County's designated marketing organization and manage and direct expenditures from the County's tourism fund.

The VCB is an organized South Carolina nonprofit organization (The VCB's Articles of Incorporation are attached as <u>Exhibit A</u>). Additionally, the VCB has applied for federal taxexempt status as a nonprofit organization.

The VCB also has a thriving tourism promotion program. The VCB is wholly dedicated to promoting tourism in Beaufort, Port Royal and the Sea Islands. The VCB's mission is to "partner with private and public organizations, businesses and government to generate economic development by marketing tourism" for the County.

Prior to the VCB's incorporation as a nonprofit organization, the VCB operated as a division of the Beaufort Regional Chamber of Commerce ("Chamber"), the County's current designated marketing organization.

As a part of the Chamber, the VCB was responsible for the Chamber's tourism and marketing programs and was largely responsible for the management of funds the Chamber received as the County's designated marketing organization. The Chamber's Board of Directors voted to separate the VCB into a separate organization and assign to the VCB complete control over the Gary Kubic, County Administrator June 22, 2011 Page 2

Chamber's tourism and marketing programs. This decision was made so the VCB could provide more focused and efficient marketing and tourism programs for the County.

The Chamber supports the transfer of designated marketing organization status to the VCB now that the VCB, as a separate organization, has assumed the tourism and marketing programs once performed by the Chamber. The Chamber has also written to the County to demonstrate the Chamber's support and echo the request to transfer the designated marketing organization status to the VCB.

As a separate organization, the VCB will continue the tourism and marketing programs it managed as a division of the Chamber and also generate new programs to draw tourists to the County. The VCB will continue to staff and operate the visitors' center, manage the website, publish informational and promotional guides and directories and be the main liaison between the region and tourists.

The VCB has proven it is a qualified organization to manage the County's tourism fund. As the successor to the Chamber's tourism and marketing programs, the VCB requests the County to designate the VCB as the County's designated marketing organization.
