BACKGROUND: Beaufort County, in partnership with the Town of Hilton Head, issued a Request for Qualifications (RFQ) to firms capable of providing professional arborist services to represent both parties during the upcoming tree removal project at the Hilton Head Island Airport. The selected arborist will assist the County and Town in performing our oversight/monitoring of the contractor hired to trim, cut, and remove selected trees at the airport. The evaluation committee consisted of three (3) staff members: Jon Rembold, Director of Airports, Larry Yeager, Chief of Operations, Hilton Head Island Airport, and Amanda Flake, Beaufort County Planning Department. Beaufort County received four (4) responses and interviewed the top two firms.

BACKGROUND. Beaufort County issued a Request for Proposals (RFP #050715E) from qualified firms to provide EM/CM and inspection services for following 7 County capital improvement projects.

1. Spanish Moss Trail Phase 2

2. Broad River Fishing Pier Rehab

3. Daufuskie Island Pier Rehab

4. Perryclear Bridge Design-Build Replacement

5. County Dirt Road Paving Contract 49

6. Animal Shelter & Control Facility

7. Buckwalter Regional Park Community Center Phase 2 Expansion

On August 17, 2015, the Public Facilities Committee was presented the award recommendation for the CM/CEI services for the projects listed. F&ME Consultants was the recommended firm. The committee requested that the award recommendation for the Spanish Moss Trail Phase 2, Broad River Fishing Pier Rehab and the Daufuskie Island Pier Rehab be presented to the Finance Committee since the budget funding source for these 3 projects is the County's Local Accommodations Tax. Public Facilities Committee did recommend an award and County Council approved a contract to F&ME for engineering construction management and inspection services totaling \$225,582 for the other 4 projects at the August 24, 2015 Council meeting. Subsequently, the Engineering Department confirmed that the Spanish Moss Trail Phase 2 budget funded from Local A Tax was approved by County Council on third reading on April 13, 2015. The budget included construction management and inspection services for the trail. So no additional action is required for these services for the Phase 2 construction. Also, no action is needed for the Broad River Fishing Pier CM/CEI services. The report on the structure engineering evaluation is being reviewed by Engineering Department Staff.

The following is a listing of the fees for the Daufuskie County Pier funded by Local A Tax that F&ME would be providing CM/CEI services.

F&ME Consultants has in-depth knowledge of construction and extensive experience with project construction management. F&ME has provided construction management services for the Bluffton Parkway Phase 5A Segment 2 roadway and flyover bridge construction and the SC 802 widening and new Beaufort River bridge construction. A selection committee consisting of the Division Directors for Construction Engineering & Facilities, Transportation Engineering and Environmental Engineering reviewed and evaluated F&ME's proposal.

On the basis of the qualification of the firm and the value offered, the selection committee recommended award of the CM/CEI Services for the Daufuskie Island Pier Rehab County capital projects listed above to F&ME Consultants in the amount of \$64,600.

FUNDING. Recommended Local A Tax funding source account for the F&ME construction management and engineering inspection services for Daufuskie Island Pier Rehab is shown above. Previously, County Council awarded the Design/Build Contract to Cape Romain Contractors for pier rehab on December 8, 2014 for \$375,000 from Local A Tax – River Beach Access. Third reading for the pier rehab design and construction appropriation from Local A Tax was completed by County Council on January 26, 2015.

Spanish Moss Trail Phase 2

DATE:

February 4, 2015

BACKGROUND. Beaufort County received a Federal (Green Corridor) grant administered by SCDOT for the design and construction of Spanish Moss Trail – Phase 2 in the maximum amount of \$1,043,520.00. It is the purpose of this project to rehabilitate the old railroad line into a pedestrian walking trail. Phase 2 is approximately 1.75 miles in length and is that section between Depot Road to Broad River Boulevard. The project work consists of clearing, grubbing, and grading the existing railroad bed to receive a 12-foot wide concrete walkway. The old railroad trestle over the Battery Creek will receive structural rehabilitation and be repurposed for the use of pedestrians and safe crossing of 10 ton vehicles. The new crossing also provides dedicated public use space for fishing. The trail, where it crosses SC170 will include a dedicated signalized crossing point and lighting. ADA compliant pedestrian crosswalks will be provided at all crossings. A number of designated rest points will be included throughout the length of the trail and the trailside areas will be grassed, mulched, and landscaped and signage for crossings and trail specific information will be installed as part of the project.

The cost projection total for the Spanish Moss Trail Phase 2 is \$2,091,826.15 to include design, construction, CEI/testing, and \$100,000 contingency for the project. The balance of the Beaufort County project funding is \$1,078,306.60 (including expenditures for design, permits, and bidding costs). The County's grant match is being funded from Local Accommodations Tax (LAT) based on Council's previous award approval of the design contract at \$271,579 from LAT. In order to move the project forward, staff is requesting the balance of County funding required to complete the project, less the amount previously approved for the design contract. The remaining budget amount requiring approval is \$806,727.15 from LAT with a current available balance of \$2.378,139. The expenditure account for the rail trail is Acct #48060011-54435.

June 2015 State Accommodations Tax Fund Financial Narrative and Analysis

The State Accommodations tax revenues are remitted on a quarterly basis from the South Carolina Department of Revenue to the County. The County has received about \$152,000 more in revenue from the State compared to June 2014. This might suggest an increase in tourism for the unincorporated portion of Beaufort County for fiscal year 2015.

The State Accommodations Tax Board meets annually to decide how to distribute the funds to the local organizations to promote tourism in the County.

The County's two designated marketing organizations (DMOs) are the Beaufort Chamber of Commerce and the Hilton Head Island-Bluffton Chamber of Commerce. These two DMOs are required to receive 15% of each quarterly remittance from the State.

The County's General Fund receives \$25,000 during the first quarter remittance from the State along with 5% of each quarterly remittance throughout the fiscal year.

County Council approved a \$200,000 transfer to the State Accommodations Tax Fund from the Hospitality Tax Fund, but this amount will be repaid in four annual installments beginning in fiscal year 2015.

This leaves an ending fund balance of \$369,892 in the State Accommodations Tax fund as of June 30, 2015.

The County should receive 1st quarter fiscal year 2016 State Accommodations Tax revenue towards the end of October or beginning of November.

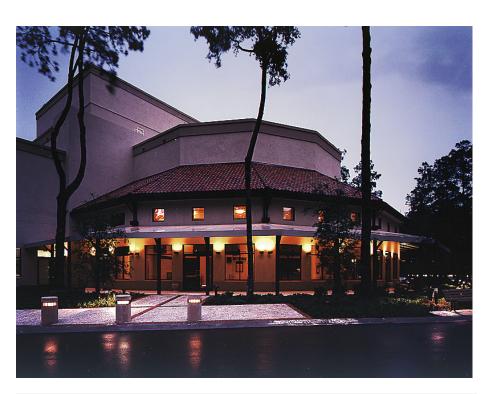

Background

- The Arts Center was built almost 20 years ago at a cost of about \$10 million without the usual municipal or university affiliations

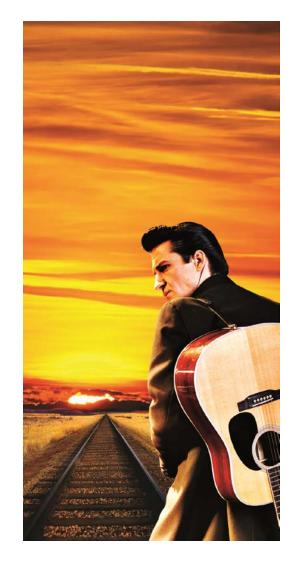

Financial Performance

- Our 2014-15 Budget was \$3.6 million with tickets & earned revenue of \$2.2 million & contributed / donated revenues of \$1.4 million with an operating contribution of \$507,000 & breakeven after facilities & interest expense
- Given no capital for facility/equipment we continually triage our needs:
 - With \$86,000 in non-recurring ATAC funds, a new HVAC controls / system was installed in late 2014 & the sound system (\$261,000) was approved in October by Town Council from non-recurring ATAC funds was installed in 2015
 - Replacing the lighting system is likely to be the next critical capital project
- Our Arts Now Campaign capital raised over \$5.0 million with about
 ½ in pledges paid over 3-5 years & ½ in legacy gifts tied to estates.
 The campaign continues with a goal of raising an additional \$1 million

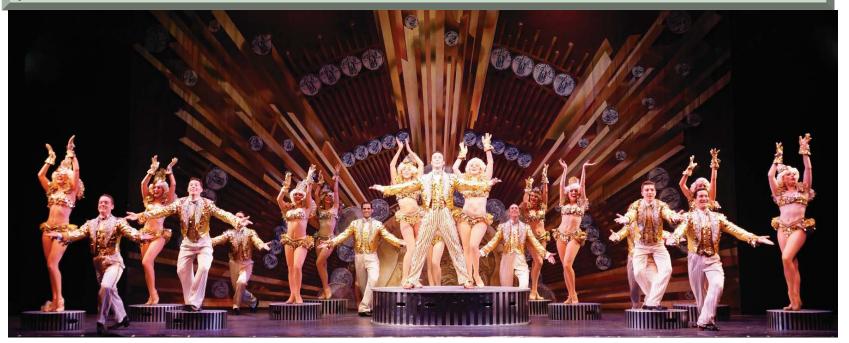

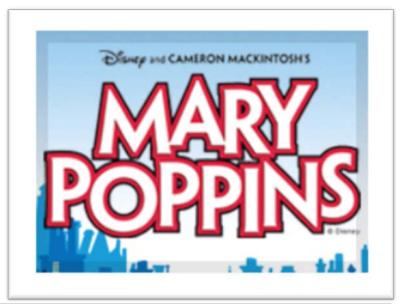
