County Council Briefing Hurricane Matthew Recovery July 24, 2017 5pm

Recovery Status:

1. Emergency Response

- a. Estimated at \$2,000,000. Staff is preparing support documentation to submit to FEMA to complete project worksheet and submit them for reimbursement.
- b. Mosquito Abatement: As per FEMA regulations, Mosquito Control was required to submit 4 years of data (average of 3 years compared to the disaster year) as an independent Project Worksheet (PW). The first of 2 PWs for the control of mosquitoes was completed recently. The reimbursement will be \$150,212. The 2nd PW is in progress for the labor associated with the service, repair, or replacement of the saltwater-contaminated aircraft components and support equipment at the hangar. Further, our aircraft underwriter paid \$83,412 among \$112,534 in claims. The remainder will be reviewed by FEMA for possible reimbursement.
- c. Billing: The "Matrix" spreadsheet summarizing project worksheet status is attached to this report. Marine debris is considered Category A work and will be reported together with road debris. Private road debris (PPDR) has been added to the Matrix.

As of this report, the County has received bills totaling:

CERE: \$27,201,583.09
 Ashbritt: \$6,292,422.64
 Tetra Tech: \$5,209,386.39

2. Road Debris

- a. Debris collection on Public and Private right-of-ways is complete.
- b. The County withdrew from the Public Assistance Alternative Procedures (PAAP) in order to seek reimbursement on the marine debris costs at the 75% rate. The request to withdraw was approved by FEMA.
- 3. Stormwater Infrastructure Related Debris
 - a. Debris collection within stormwater infrastructure areas is complete.
 - b. Tetra Tech is preparing the needed documentation to submit to USDA-NRCS for reimbursement.

4. Marine Debris

- a. Water borne debris collection is complete.
- b. Boats: All boats were retrieved from the water by 7/3/17.
- c. The County is managing two aggregation sites to temporarily hold the boats found by Ashbritt during the survey that have not yet completed the abandonment process by DNR.
- d. Cost: Current estimated cost is \$6,705,451.15

1. Infrastructure Damage

- a. Flyover Bridge (Exit 5A) Slope erosion: Staff is considering a couple of options to complete the work by contract or in-house. No decision has been made at this time.
- b. Central Drive Culvert replacement: Complete.
- c. Spanish Moss Trail slope erosion: Work is complete.
- d. Boat Ramps (marinas) and Docks: Repairs are almost complete. \$199,250 contracted amount. FEMA reimbursement is based on \$184,996. Adjustments have been made due to insurance deductions. See Summary of Projects. Schedule is 180 days ending 10/14/17.
- 2. Facilities Damage (significant items only listed)

- a. Lady's Island Airport: Currently in FEMA insurance review. Emergency Repairs are complete. Staff prepared additional documentation associated with the long term repairs to the runway lights and associated mitigation projects with an estimated cost of repairs of \$370,186. This was submitted to FEMA. We have not received a response at this time.
- b. Fences on County properties throughout the County: Staff estimate = \$42,335. FEMA PW estimate is \$47,709. Reimbursement will be based on actual costs. Work is ongoing.

3. Individual Assistance

- a. SC set up the Palmetto Disaster Recovery Office. Location in Building 6 at TCL Beaufort Campus. M-F 8:30am-5pm. 1-888-860-7137. Case managers can assist FEMA IA applicants with continued needs.
- b. The Palmetto Disaster Recovery Office will be holding three application intake events for individuals who still have unmet needs due to Hurricane Matthew. Monday July 24 and Tuesday July 25 will be at Brick Baptist Church from 2:00pm-8:00pm. Wednesday August 2 will be at Buckhead United Methodist Church from 2:00pm-8:00pm.
- c. Palmetto Disaster Recovery currently has 74 active cases and has completed 61 home visits.
