Rusty showed a list of the roads that would be included in Year 9 Preservation. A motion was made by David Johnson and seconded by Ginny Kozak to fund the \$341,247.55 for the rejuvenation project. The vote was unanimous.

David Johnson made a motion to fund the microsurfacing. estimated at \$676,657.39 with a condition of an additional 5% contingency to account for striping. Vice Chairman Handman seconded the motion. The motion passed unanimously.

D. SOMERSET POINT HOA

The Homeowners Association of Somerset Point, on Ladys Island, requested that some of their roads, within the HOA, be accepted as county roads. A motion to reject the acceptance of these roads was made by Charles Perry. Craig Forrest made the second. The vote, to reject accepting these roads into the county system, was unanimous.
