# C. PALMETTO BAY ROAD & BRIDGE APPROACH UPDATE

A letter was received from South Carolina Department of Transportation requesting the concurrence for a Recommendation of Award to Preferred Materials, Inc., for the resurfacing of 1.470 miles on Palmetto Bay Road (US 278 Business) from Charles E. Fraser Bridge to Sea Pines Circle. In addition to the Bridge Approaches for the Cheechessee River, Broad River and Chowen Creek in Beaufort County. The total cost of this project, after adding in the Preliminary Engineering costs, Construction, Engineering, & Inspection (CE&I), and the contingency is \$2,567,547.20.

# D. STILLWELL ROAD UPDATE

Stillwell Road is a private road that was developed to feed a subdivision and overtime, developed residences along the road. The residence of the subdivision have historically maintained the road. It has been requested by the residential community that Stillwell Road is considered and accepted into the Beaufort County Road Network. It is stated in the BCTC Transportation Plan that "all privately maintained dirt roadways shall be brought up to accepted paved County Engineering Department design standards to include all the necessary right-of-way and drainage easements in advance of consideration." Stillwell Road does not conform to established criteria for acceptance into the county road network.
