Along with a 200k down payment from DIFD Reserve Funds, Commissioners requested a FY'25 debt service mil rate increase to accommodate the purchases of 2 vehicles as described with an anticipated delivery in March 2024. Purchase through HGACBuy Cooperative Purchase Agreement. Chief to continue procurement process with County and Vendor. Mason requested a move to approve, motion made by Brunning and seconded by Rafferty. All in favor.
  - Full-Station Generator: Chief Comparetto presented request for purchase through Sourcewell. Mason requested a move to approve purchase of \$25,029.04 with an amendment to include cost addition for an increase in tank size, motion made by Brunning and seconded by Rafferty. All in favor.
