December 2014 Rural and Critical Lands Program Financials Narrative and Analysis

The Rural and Critical Lands Program currently has \$12.47 million in funds as of December 31, 2014. This amount is comprised of \$11.11 million in unrestricted funds and \$1.36 million in restricted funds, which have donor specific restrictions on how these funds can be used.

The \$25 million bond, which was issued in May 2013 as a result of Beaufort County voters approving the referendum in November 2012, has been used for various property acquisitions, infrastructure development, passive parks, and administrative costs throughout the County.

These financials also do not include the recent voter approved \$20 million bond referendum in November 2014. The Finance Department expects to receive these funds in Spring 2015, but the County's bond counsel will set the official timeline for this process.
