County General Fund

The County's General Fund revenues for the second quarter of fiscal year (FY) 2013 are \$54.5 million as of December 31, 2012. Last year's second quarter General Fund revenues were \$54.2 million. See page 5 for a comparative General Fund revenue chart. General Fund expenditures for the second quarter of FY 2013 are \$46.2 million, which compares to last year's second quarter general fund expenditures of \$45.1 million. See page 8 for a comparative General Fund expenditure chart.

The \$.3 million increase in revenues and \$1.1 million increase in expenditures are mostly the result of the following factors:

- 1. The County's revenues are \$.3 million more as of December 31, 2012 as compared to December 31, 2011. The South Carolina State Aid distribution increased by \$1.0 million to Beaufort County as a result of the 2010 United States Census population increase within the County. The \$1.0 million increase within State Aid to the County was partially offset by a \$0.6 million decrease within current ad valorem tax revenues. This decrease is mostly a matter of timing, as total FY 2013 current tax collections as of January 15, 2013 totaled \$62.7 million, which compares to \$62.6 million as of January 15, 2012.
- 2. The \$1.1 million increase in General Fund expenditures is the result of the \$1.2 million increase in personnel expenditures. This was primarily caused by the 2% cost of living adjustment granted to County employees as a part of the FY 2013 budget and the corresponding increases within the County's State Retirement System contributions and federal withholdings.

In conclusion, the County's General Fund balance is within the mid-year FY 2013 budgeted range. Administration expects the rate of expenditures in the second half of FY 2013 to stay at the levels of the first half. Revenues are expected to stay roughly even with FY 2012, as ad valorem tax collections are expected to be slightly lower than FY 2012, however this will be offset by larger State Aid revenues within FY 2013. The County will continue to monitor both rates of expenditures and revenue collections and notify Council of any material changes.

County Debt Service Fund

The County's Debt Service Fund revenues through the end of the second quarter of FY 2013 are \$6.8 million, which compares to \$7.0 million through the end of FY 2012's second quarter (see below for details on this planned difference). See page 6 for a comparative County Debt Service Fund revenue chart. Furthermore, the County's Debt Service Fund expenditures for FY 2013 are \$3.7 million, which is \$.2 million less than FY 2012's second quarter and in-line with the County's budgeted annual debt service payments. See page 9 for a comparative County Debt Service Fund expenditure chart.

As the County has refinanced several of its bonds over the last number of years, debt service payments have grown smaller within FY 2013 as compared to FY 2012. As such, millage was lowered in FY 2013 from 4.57 to 4.44. This is in-line with the County's Debt Service Fund balance policy, in which millage is to be set at actual levels of debt service needed within the corresponding fiscal year.

In conclusion, the County's FY 2013 Debt Service Fund revenues and expenditures as of December 31, 2012 are slightly lower than where they were in FY 2012. This is in line with the fiscal year's debt service requirements and corresponding budgeted Debt Service Fund's millage.

County Purchase Property (Referendum-Voted) Debt Service Fund


The County's Purchase Property Debt Service Fund revenues through the end of the FY 2013 second quarter are \$4.1 million, which compares to \$3.0 million through the end of FY 2012's second quarter. Furthermore, the County's Purchase Property Debt Service Fund expenditures for FY 2013 as of December 31, 2012 were \$1.8 million, which compares to \$1.6 million at the end of FY 2012's second quarter. 
Both increases in revenues and expenditures correspond with the increased debt service requirements within the FY 2013 County Purchase Property Debt Service Fund. This relates to the additional \$10 million borrowing in mid-FY 2012. The debt service payments for the additional borrowing began coming due in FY 2013. As such and inline with the County's Purchase Property (Referendum-Voted) Debt Service Fund balance policy, millage was set in FY 2013 to obtain the higher level of debt service needed within the current fiscal year.


In conclusion, the County's Purchase Property Debt Service Fund revenues and expenditures are higher than they were at the end of the second quarter of FY 2012. This relates to the additional \$10 million referendum-approved borrowing transacted in mid-FY 2012, which increased FY 2013's debt service requirements in this fund.



This contribution will end once the New River TIF bonds are paid in full and the County advance is also paid in full.

Conclusion: The Bluffton - County TIF bonds will be paid fully on February 1, 2013. The remaining amount owed will be refinanced with a new lendor at a much lower interest rate. As such, this TIF is estimated to be fully paid off by the end of FY 2017 or beginning of FY 2018 (which is 10 years earlier than anticipated at the beginning of this TIF). The County's General Fund contributed over \$372,000 to the Bluffton - County TIF in FY 2012, or approximately .21 mills. This contribution will end once the Bluffton - County TIF bonds are paid in full.
