4. **SUB-COMMITTEE UPDATES:**
 - a. **EDUCATION AND LITTER ENFORCEMENT:**
 - i. Ms. Floyd- DOT mowing prior to picking up, they have mowed election signs. Mr. Rodriguez has reached out to SC DOT regarding the issues to potentially remediate the situation. Palmetto Pride issues funds for the efforts to pick up prior to mowing. Solid Waste staff will assist in the efforts of clean up.
 - ii. Ms. McFee reported that Courney Kimmel with Port Royal Sound Foundation (PRSF) is working on legislative efforts of the bag ban ordinance. She is also working on children's art programs for the Marine Center.
 - iii. Mr. Campbell reported that there is a new recycling center in Savannah and it is potential place for the group to tour.
 - b. **LEGISLATIVE:**
 - i. Bag ordinance – Ms. McFee is working with PRSF for outreach with children. She will reach out to Valentina for environmental education efforts. She is working with a small group to move the efforts forward.
 1. There is a proposed questionnaire to go out to residents and businesses still in draft form to gather information on plastic bag use. McFee will share meeting notes from the last workgroup meeting.
 2. The team want to ensure that the municipalities will also pass the bag ban with the County.
 3. Ms. Floyd will reach out to other groups such as Fripp Island to see if they would like to get involved. A group discussion occurred on other possible groups who would be willing to join them.
 - ii. Enforcement of plastic bag use in Beaufort County – Officer Riccobene will investigate it. Beaufort County code enforcement assistance will be requested.
 - c. **BEAUTIFICATION:**

- i. Mr. Cambell- The Greenery will be planting flowers at the traffic circle by Shanklin Elementary School. Funds allotted from Beaufort County will be used.

5. STAFF UPDATES

- a. Palmetto pride grants- Chloe has placed orders for all items.
 - 1. The Board would like to extend the billboard to 3 months on 170.
 - a. Ms. Voge proposed to extend Hwy 170 for 2 more months using County funds for a total of 3 months.

 - b. Mr. Cambell – potential to run the same billboard in May/June.
