 - a. EDUCATION AND LITTER ENFORCEMENT
 - b. Ms. McFee spoke about litter control being enforced properly. Mr. Campbell, Ms. Hoffman, and Ms. McFee met to discuss the grant. No formal approval yet. Ms. McFee asked that all questions be directed to her.
 - c. Per Mr. Bartholow and Mr. Campbell there is limited action on the litter enforcement. Intersection on Hwy 170 and Hwy 46 looks horrible per Bartholow and needs to be addressed.
 - Ms. McFee Asked if either highway was covered by Adopt a Highway.
 - d. Ms. Voge proposed about having a vendor/contractor in place regarding litter enforcement.
 - Ms. Hoffman, Mr. Dasai, and Mr. Campbell had a meeting regarding using an outside contractor and are possibly considering the idea.
 - Other Ideas: Picking up litter prior to mowing lawn, considering having 4-5 individuals to pick up debris.
 - Ms. McFee questioned if there is a recourse in place or support to assist in Litter Control. To include working on a Budget.
 - Mr. Bartholow would like to install cameras (at his cost) to screen tags for litter Control and start fining individuals.
 - FY 2026 will include litter picker equipment and FY 2025 (2) Public Works Enforcement Officers to get proper training as well as a litter crew contractor.
