CALL TO ORDER

The meeting was called to order by **Bruce Yeager**. There is no quorum.

APPROVAL OF AGENDA

Bruce Yeager asks for an addition to the agenda, which is to approve the 2024 board meeting dates. There is a motion to add that item to the agenda and all agree. Agenda is approved. Bruce Yeager addresses Rob Mondavi and verifies that Rob Mondavi is attending this meeting to make a change to a previously agreed upon fee change. Bruce Yeager states that when there is a guorum, Rob Mondavi can bring his case to the board for review.

Mr. Blackmon states that the Charles Lind Brown Center has been neglected for at least ten years by the County. Mr. Blackmon states that programming is needed at the Center, and that the population nearest to the center is elderly, and that they don't always use the website. He states that his group would be willing to put programming information in his group's newsletter. 
