Special Olympics will be using our Bluffton Center gym to get in some of their practices. We continue to host our private and public schools using our facilities.

Shane Stager stated that we are in the infant phase of planning the new community centers at Agnes Major and Wesley Felix. Booker T. renovation will be starting soon. Charles Lind Brown will be getting a face lift in the gym, new floor, bleachers, rims. We are not advertising a reopen date for Bluffton Pool. The walls for Bluffton Pool are expected at the end of the month. There is a planned renovation for the Bluffton Center, which includes the Senior Center and the gymnasium building. We are in the planning stage for the fields. The larger baseball fields and soccer fields are getting turf. At Shell Point Park, there has been root intrusion, they are closed for safety reasons. We are getting quotes to have them resurfaced. Southside Pickleball has new pickleball courts and a basketball court. Some of the pickleball courts are puddling so they need to be resurfaced so they are closed.

Shane Stager states that we will be watching the continued resolution from the fiscal side, as our senior programs are funded heavily by the federal government. If the budget isn't passed, we will need to start looking at how to keep things running, most specifically the dining piece.
