The regular meeting of the Beaufort County Northern Regional Plan Implementation Committee (hereinafter "Committee") was held in Executive Conference Room on Friday, May 26, 2023 at 9:00 a.m.

CALL TO ORDER: Chairman Ed Pappas called the meeting to order at 9:02 a.m.

PLEDGE OF ALLEGIANCE: Mr. Pappas led those assembled in the pledge of allegiance.

REVIEW OF MEETING MINUTES: Council Member York Glover made a motion to approve the April 28, 2023 minutes. Mayor Joe DeVito seconded the motion. The motion passed unanimously.

CITIZEN COMMENTS: Mr. Pappas asked if there were any non-agenda citizen comments. There were none.

PRESENTATION:

Ms. Stephanie Rossi, LCOG, explained that she had set up a virtual meeting with SCDOT and FHWA representatives, Christina Lewis, Lyle Reed, Joe Stearn, Jim Wilden, and Mark Pleasant, at the request of the members of NRPIC, to discuss the potential of an additional MPO. She mentioned that there was not a formal presentation, but she had included some discussion questions in the agenda packets.

After much discussion, the overall decision was to not create a new MPO but remain together in the current MPO.

DISCUSSION ITEMS - UPDATES:

Mayor Stephen Murray gave an update on the Metropolitan Planning Commission. He stated that the City of Beaufort is going to stand up its own Planning Commission and combine it with the City's Design Review Board to develop a more comprehensive review for development projects. He also mentioned they are making staff changes and brining in architects and senior planners and working on 140+ code changes over the next nine months. Council Member Alice Howard made a comment, for the record, that she didn't think that it was a good idea.

Mayor Murray brought up the idea of having a spot on the committee for the military. Mrs. Howard mentioned that they'd previously held an ex-officio seat. Mayor Joe DeVito confirmed that the military had an ex-officio seat in the past but wasn't sure why they no longer came. Mary Ryan Krieger was asked to look further into it, with the military, for next month.

ADJOURNMENT: Chairman Pappas adjourned the meeting at 10:05 a.m.
