Discussion:

- Chairman Ed Pappas introduced some visitors from the Senior Leadership Beaufort group: Mr. August Ghessie, Ms. Lisa Ghessie, and Ms. Judy Cole.
- Councilman Brian Flewelling stated that he brought forward a request from this Board for a Passive Park Task Force to the Natural Resources Committee. This request was approved and Councilman Flewelling and Councilman Paul Sommerville are working on populating this Task Force. Councilman Flewelling suggested that a couple of members from this Board should be on the Task Force. Hopefully by mid-April this Task Force will be implemented.
- Councilman Flewelling announced that County Council is possibly bringing forward a 2014 Bond Referendum for the Rural and Critical Land Preservation Program. He would like the Board members to weigh in on the referendum language. Councilman Flewelling will send the proposed referendum to the Board members so that it can be discussed at the April Board meeting.
- Ms. Patty Kennedy stated that she is continuing to move forward with updates to the Greenprint. The initial drafts of St. Helena and Hilton Head Island are finished. She is currently working on Lady's Island and the Burton/Dale areas. The maps should be ready to come out in May at which time this Board needs to decide how to present this information to the public.
