CALL TO ORDER

Chairman Ed Pappas called the meeting to order at 3:03 p.m.

REVIEW OF AGENDA

Chairman Pappas asked if there were any changes to the Agenda and there were none.

REVIEW OF MINUTES

Chairman Pappas asked if there were any changes to the Minutes from the June 26, 2014 Board meeting. Hearing none, Ms. Sullivan made a motion and Vice-Chairman Brown seconded the motion to accept the Minutes as written from the June 26, 2014 Board meeting. The motion was carried unanimously to accept the minutes as written from the June 26, 2014, Board meeting (FOR: Pappas, Brown, Bender, Glover, Sullivan, Stewart).

GENERAL DISCUSSION

Mr. Alan Eisenman gave a financial update of the Rural and Critical Land Preservation (RCLP) Program. As of June 30, 2014 the RCLP Program has \$14.5 million in funds. Of this total, \$13.1 million is unrestricted and \$1.4 million is restricted.

Chairman Ed Pappas introduced Mr. Ken Driggers, Beaufort County Open Land Trust Attorney, who is one of the new liaisons for the RCLP Program along with Lisa Lord. Mr. Driggers background is exclusively land conservation and he has represented nine different land trusts over the years. Before that he ran a non-profit organization for twenty years.

Mr. Driggers stated that the 2014 November bond referendum request passed all three readings at County Council. The referendum will include up to 20% of the bond reserved for improvements to properties.

Mr. Driggers said that Beaufort County Open Land Trust is working on an educational promotion of the RCLP Program. BCOLT will be updating the RCLP Facebook page and website and will try and do some public speaking arrangements.

Mr. Driggers said that the Greenprint process was finished and a final map had been produced and adopted by County Council. The map does not detail specific properties rather it has bubbles around areas of interest. Mr. Driggers stated that the program is not looking to purchase all the undeveloped properties that fall in these bubbles these are just areas that were a product of all the stakeholder meetings.

EXECUTIVE SESSION

Chairman Pappas entertained a motion by Mr. Glover, seconded by Vice-Chairman Brown, to adjourn the Open Session at 3:44 p.m. and convened Executive Session for the purpose of discussing matters associated with property acquisitions. **The motion was carried unanimously to enter into Executive Session** (FOR: Pappas, Brown, Bender, Glover, Sullivan, Stewart).

Chairman Pappas adjourned Executive Session and convened Open Session at 4:11 p.m.
