CALL TO ORDER

Chairman Mike Mathews called the meeting to order at 3:00 p.m.

REVIEW OF AGENDA

Chairman Mathews asked if there were any changes to the Agenda and there were none.

GENERAL DISCUSSION

Financial Update

Ms. Amanda Flake gave a financial update of the Rural and Critical Land Preservation Program (R&C Program). As of January 31, 2016 there was a total amount of \$6.18 million in funds. These numbers do not include the \$20 million referendum that was approved in November 2014.

Board Information

Chairman Mike Mathews would like to remind all the Board members to sign into the dropbox and review the information provided about the R&C Program. The dropbox is constantly being updated by Ms. Lisa Lord.

Passive Park Update

Mr. Tony Criscitiello stated that building permit was issued for Crystal Lake this week and that work would begin soon. Fort Fremont is in the last stages of the archeological investigation. The next step would be to apply for permits and then send the project to bid. Okatie Preserve is involved in meetings with the architect and engineer and will soon go to the Town of Bluffton for approval.

Friends of Crystal Lake

Ms. Peggy Allard showed a presentation about the Friends of Crystal Lake group. Crystal Lake Park is located on Lady's Island and consists of 26 acres of property purchased over time through the R&C Program. It also includes a six acre lake that used to be a borrow pit. The lake is a unique mixture of salt and fresh water. During the process of creating the park, a boardwalk and pier were built out to the lake. Unfortunately the pier was burned which reinforces the issue that security is needed on site. There have been collaborations with other non-profits organizations and agencies to enhance the value of the Crystal Lake property. The South Carolina Foresty Commission gave Crystal Lake a grant to remove invasive tallow trees and create a foresty management plan. A bioblitz with Master Naturalists and Master Gardeners was conducted to determine what kinds of flora and fauna exist on site. The next focus of the Friends group is to work on signage for the park. Board members of the Friends group include Master Naturalists, Master Gardeners, Beaufort County staff, and Beaufort County School District staff.

Project Updates

Ms. Lord gave an update on the Boundary Street project. She stated that the Huddle House is closing the first week of June. The City of Beaufort will be closing on Sea Eagle Market soon and the Beaufort County Open Land Trust has already closed on the United Way building. Ms. Lord stated that County Council approved funds to purchase the Jeter and Mobley tracts off of Hwy 170 and there will be an article in the paper tomorrow.
