## **DISCUSSION ITEMS**

### **Greenprint Update**

Mr. Greenway stated that Design Workshop had been hired by the Community Development Department to assist with the Comprehensive Plan update. He recently requested that Design Workshop add an amendment to their contract to perform the Greenprint update. This amendment is scheduled for the Natural Resources Committee meeting for April 6, 2020 for approval. Mr. Greenway stated that the Community Development Department has already had two kickoff Comprehensive Plan Update meetings and plan to have two more in May.

### **RCLPB Finance Report**

Chairman Mathews presented an overview of the Rural and Critical Land Preservation Program Finance report ending March 31, 2020. He wanted to thank Mr. Chris Inglese and Mr. Hayes Williams for help in revising the financial report to clarify some questions. Currently the Program has approximately \$199,478 that includes the encumbrances. Chairman Mathews stated that Mr. Williams would provide quarterly reports throughout the year.

### **RCLP Flow Chart**

Ms. Barbara Holmes presented the updated flow chart. The flow chart shows a snapshot of the process to include major points in land acquisition where staff, Rural and Critical Board member, the Natural Resources Committee, and County Council are making decisions.

This application will eventually be available online. Once a quarter staff and Beaufort County Open Land Trust will rank and submit these applications to the Rural and Critical Board for a decision on which projects to move forward.
