DISCUSSION ITEMS

Financial Report

Chairman Mathews introduced Ms. Whitney Richland, the new Beaufort County Finance Director. He then introduced Mr. Hayes Williams who discussed the latest R&C financial report. Mr. Williams stated that the 25 million dollar bond revenues were received into the Program. As of September 2020 the R&C Program had \$20,777,469 available. Chairman Mathews added that with committed projects the amount to be used for future purchases was closer to \$19 million.

Greenprint Update

Chairman Mathews stated last month that Design Workshop would be sending the Board a draft of the Greenprint plan for the Board to review. Ms. Flake stated that the timeline was recently delayed. According to the revised timeline the draft would be available November 20th, comments would be due back to Design Workshop on December 9th, revisions would be sent back to the Board on December 16th, and final adoption of the Greenprint plan would happen around January 14th.

R&C Application Process

Mr. Greenway stated that the application process is a new dynamic to the R&C program. In the ordinance it states that applications are received and reviewed by County staff and the consultant, ranked by staff and consultant, and then brought forward to the Board for review. If the Board denies the applications they are still sent to the Natural Resources Committee for review. If the NRC denies the applications, then the applicants are sent notifications that the projects were not accepted into the program. The two projects that were reviewed last month will go forward to NRC on December 7th for recommendations of denial. The Board requested that a list of all applications received, including the ones that did not meet the standards of the program, be submitted to the board for information. The Board then asked about the status of the consultant for the program. Mr. Greenway stated that the RFQ bids were rescinded and a new RFQ was going to be written with modifications and put back out to bid soon. In the meantime, the County was going to enter into a 3 month contract with the Beaufort County Open Land Trust as the consultant for the R&C program.
