#### **R&C Monthly Notes and Updates**

Ms. Schaefer stated that applications are submitted quarterly and the 2<sup>nd</sup> quarter closed at the end of June 2021. The applications are available online. This quarter there were five different projects that were reviewed and will be seen at this meeting and in August. We had a R&C Board Retreat in June that went very well. We usually hold a retreat for the Board once a year. During the retreat the Board said that they would like to start doing field trips to sites in the future. Ms. Schaefer will be working on these outings. She also wanted to update the Board that the Beaufort County Open Land Trust has submitted an application for the Sentinal Landscape Program, modeled after what exists in the State of Georgia where the State of Georgia and the military installation have worked with the federal government to designate areas of priority for land stewardship and acquisition. Ms. Schaefer said that there are several groups in this area that would be interested in this type of protection and might be willing to partner with this type of proposal.
