Mr. Joe Mack, a member of the Beaufort Trailblazers (mountain bike trails), was willing to donate money and volunteers to try and build mountain bike trails on some of the Beaufort County passive parks. He had submitted a proposal to Beaufort County with details and told the board members to explore the Savannah White Marsh Preserve website to see an example of trails that were built by this group.

#### **PRESENTATION**

#### The Nature Conservancy

Ms. Katy McWilliams presented information about The Nature Conservancy (TNC) which is a 501 c3 conservation organization and has been in South Carolina since 1969. This organization holds around 160 conservation easements in South Carolina which amounts to around 180,000 acres preserved. The first conservation easement held by TNC in South Carolina was St. Phillips Island in 1983. The mission of TNC is to conserve land with one avenue being conservation easements. TNC's role is to identify conservation values on properties such as special natural features, habitat for certain species, and rare habitats in South Carolina. Each conservation easement is different and unique and is constantly adapting over time.

#### Finance Update

Ms. Amanda Flake stated that as of June 30, 2021 the R&C Program had \$19,654,991 available for purchases. However, during the meeting it was discovered that the report was incorrect. The report was dated through December 31, 2020, not June 30, 2021. Therefore Ms. Flake will request that Mr. Hayes correct the report and then a copy will be sent to the board.
