DISCUSSION ITEMS

Finance Update

Mr. Hayes Williams stated that as of December 21, 2021, the R&C Program had \$15,447,987 available for purchases. Ms. Stefanie Nagid stated that the Fort Fremont project is now complete and there will be no more encumbered funds for that line item. Ms. Nagid will present a Passive Park Update including financial information at the Retreat in May.

Proposed Additional Language for Application

Ms. Schaefer provided the Board members with the current Rural and Critical Land Preservation Program Application for review. After some discussion the following were suggestions from the Board members:

- 1. Mark information that will be available to the public with an asterisk.
- 2. Do not make the price expectation public.
- 3. Add information about prior contamination on the property.
- 4. Do not make the address and phone number of the applicant or owner public.
- 5. Add information about any encumbrances on the property.

Discussion of when projects should be in Executive Session

After some discussion by the Board, it was decided to leave the Executive Session line item on the agenda as a place holder for each meeting, whether it is needed or not.

Monthly Update

Ms. Kate Schaefer stated that the deadline to turn in projects for Quarter 1 is March 31, 2022. So far there had been one application and six inquiries. On March 4th some of the Board members attended a site visit to the Three Sisters Farm. This property was protected with a conservation easement through the Rural and Critical Land Preservation Program in 2004 to protect a working landscape. Ms. Schaefer recorded the visit and made a great video of the trip. On March 24, 2022, the Board members will have a chance to take a boat tour down the Wimbee Creek to view the latest conservation easement purchase of Oak Point.
