DISCUSSION ITEMS

Greenspace Sales Tax Referendum

Ms. Schaefer stated that the Greenspace sales tax referendum passed third and final reading at County Council on Monday and will be put on the ballot in November. It will be a penny sales tax that will begin in May of 2023 and will either run for two years or collect 100 million dollars, whichever comes first. There will be discussion of how to administer this referendum at the next Natural Resources Committee on Tuesday, September 6, 2022.
