DISCUSSION ITEMS

Project Ulmer Road

Ms. Stefanie Nagid presented this project since it came about through the Beaufort County Legal Department and then to staff. An application was submitted by the seller and due diligence has already been performed. This property is located at 34 Ulmer Road in Bluffton and is approximately 41 acres. The property is immediately adjacent to Bailey Memorial Park and includes part of the wetland system that runs through Bailey Memorial Park. It has a pond on the property as well as a cell tower. The property price is \$3.15 million.

Community Heritage Farms

Mr. Ernie Wiggers and Ms. Cathy Isbell represented the Community Heritage Farms that was created in 2020. According to Mr. Wiggers there was a need for community farms in northern Beaufort County so this group started one at Whale Branch Elementary and Middle Schools. They are now a 501. They have a greenhouse, raised garden beds, are assigned to specific classes in the schools, and get many students involved. The farm produces collards, broccoli, sweet corn, and promotes pollinator gardens. Check them out on Facebook.

Monthly Project Update

Ms. Kate Schaefer shared that Project Cotton Hall was approved in July and will close sometime in September. Project Cherry Hill Oak was also recently approved and will close in September. There are still some due diligence items to be completed for Project Beach City Road, Project Barrell Landin Orr, and Project Boundary Street. Currently the remaining funds in the program are \$2.6 million.
