DISCUSSION ITEMS

Project Boundary Street Logan

Ms. Kate Schaefer stated that this project was part of an upper Boundary Street corridor similar to Lower Boundary Street that consisted of shallow lots with marsh views that would enhance the entrance to Beaufort and solve some traffic issues. This application had been held until neighboring properties showed movement. The OLT had a right of first refusal on a few of these properties. The City of Beaufort just closed on the Sherbert property in December which would be the other bookend for this project. Boundary Street Logan is 0.81 acres and is appraised at \$335,000.00. The Board suggested that Ms. Schaefer and Ms. Flake rank the property and bring it back for a vote in February.

Monthly Project Update

Ms. Kate Schaefer shared that if all projects in the que move forward, the R&C Program would have \$251,000.00 left in the budget. Currently one project may not happen which would put \$1,000,000 back into the Program. Project Barrell Landing Orr will go to County Council for approval to purchase on January 22, 2024. There were still some due diligence items to be completed for Project Beach City Road, Project Station Creek, Project Davis Road, Project Rawstrom Road, and Project Seaside Road.
