CALL TO ORDER

Vice-Chairman Gloria Cartwright called the meeting to order at 3:03 p.m.

Vice-Chairman Gloria Cartwright asked if there were any changes to the Agenda. Mr. Glenn Stanford added two items: to discuss some proposed rules and procedures for the RCLPB Board, and to review the statistics of the RCLPB program.

Vice-Chairman Gloria Cartwright asked if there were any changes to the Minutes from the September 11, 2008 Board meeting. Hearing none, Mr. Goodridge made a motion and Mr. Vercellotti seconded the motion to accept the Minutes from the September 11, 2008 Board meeting. **Motion carried.**

GENERAL DISCUSSION

During the last meeting, it was discussed that the orientation meeting (designed to inform other local governments about the RCLPB program) was going to be held in January, possibly at the Marine Corps Air Station. Mr. Pappas and Mr. Goodridge stated that they would help coordinate this meeting and will bring forward some information next month.

Mrs. Billie Lindsay, with the Beaufort County Planning Department, gave an update on the Rails to Trails program involving the Port Royal Railroad line. The County developed an RFQ (Request for Qualifications) for a railway conversion feasibility study. Ten firms responded and a selection committee rated the applications and will begin discussion on the scope of work with the top ranked firm soon. Mr. Glover asked if the public would be involved. Mrs. Lindsay confirmed this question and said that there would be public workshops held throughout the process.

Vice-Chairman Gloria Cartwright read an email from Chairman Riley about his meeting with Councilman Paul Summerville to discuss the RCLPB Charter. The email stated that there were a few typos to fix and that Mr. Summerville had a question about the limitation of active park land. The Board discussed the question of what defines an active or passive park and decided that at some point, definitions of both types of parks should be determined and should be included in the RCLPB language.

Mr. Glenn Stanford said that during this meeting between Chairman Riley and Councilman Summerville, there was a set of RCLPB Rules and Procedures that was found that had no relationship on how this Board is now conducted. Therefore, Mr. Stanford distributed some new proposed rules and procedures for the Board to review and consider for the next meeting. Mr. Stanford also showed a history of the RCLPB program and what is has accomplished to date. Some of the totals so far are as follows: Total acres saved: 16,751.8 Worth: \$106,598,250
We paid: \$63,849,015 which is 60% of fair market value and these purchases saved 6,465
