Beaufort County Rural and Critical Land Preservation Board meeting November 10, 2011

CALL TO ORDER

Chairman Malcolm Goodridge called the meeting to order at 3:02 p.m.

Chairman Goodridge asked if there were any changes to the Agenda and Vice-Chairman Ed Pappas suggested that we add an agenda item addressing the speaker who will be coming to talk about bond referendums nationwide.

Ms. Patty Kennedy reported that the Rural and Critical Land Preservation Board recommendation for the 2012 Bond Referendum had moved forward to County Council with the first reading having an almost unanimous approval (County Councilman Gerald Dawson voted against the Referendum). County Councilman Paul Sommerville stated that Councilman Dawson's vote was not in opposition of the program, but was in relation to something else he had voted on recently.

Ms. Kennedy announced that Beaufort County Open Land Trust had lined up a speaker, Will Abberger, to come and address the Rural and Critical Land Preservation Board about national polling and trends with bond referendums for land conservation. Ms. Kennedy and Mr. Garrett Budds heard Mr. Abberger speak recently at a conference and he said that overall people are still voting for land conservation even in this economy. Mr. Abberger will hopefully be here for the December Board meeting.

Mr. Budds said that Open Land Trust staff and County staff were still working on the property classification update to put into the Comprehensive Plan and were hoping to take this amendment to the Natural Resources Committee sometime in January.
