- \$ Chairman, Doug Robertson called the meeting to order and welcomed everyone.
- \$ Mr. Robertson asked for a motion to adopt the minutes. A motion was made and seconded. Minutes were adopted as written.
- The monthly reports were presented for August and September 1999. The discussion focused on the September reports. A straight line comparison of yearly disposal expenditures shows that the budget is a slightly higher than it should be at this time in the budget. Mr. Bellamy added that he is looking for alternatives to cutting the costs for disposal by separating brown goods from other bulky items.
- \$ Mr. Bellamy reported about the on-going discussions between Beaufort County and the Town of Hilton Head regarding Solid Waste and Recycling services on the island. A meeting was held on November 5, 1999, with Chuck Hoelle, Assistant Town Manager for the Town of Hilton Head. Items discussed were as follows:
 - \$ Timeline for implementation and costs

- \$ Commercial Route for recycling and the vehicle used for the route
- \$ Employment of current LCRA employees
- \$ Information regarding satellite sites for recycling: Gullah Market, Shelter Cove, Port Royal Plaza and Dunnagan's Alley.
- \$ Mr. Bellamy also reported on the progress for increasing the charge for the disposal of commercially-generated MSW. An increase to \$17 / ton will take effect on February 1, 2000. Staff is also working with Waste Management to determine the timetable for future increases, which will eventually lead up to the full cost for disposal.
- \$ Mr. Bellamy added that he would be taking a trip to Richmond, VA for a site visit with Grind-All sometime during the next two weeks.
- \$ Mr. Robertson asked for announcements.

The next board meeting will be Thursday, December 16, 1999 at 2:00 pm in the Conference Room.

\$ Mr. Robertson adjourned the meeting.
