- The minutes for the April 2006 meeting were read and approved with the following correction:
 - 0 Mr. Bowers is in district 7, must be noted that District 6 is vacant
 - It was also noted that Laura Bailey returned to the Town of Bluffton. We will check to see if she is going to continue as District 4 Ex-Officio.
- The monthly report for February was reviewed and accepted.
 - Recycling tonnage should approach 6,000 tons this year.
 - HH commercial tonnage was down indicating that haulers are not taking it to WM or that WM has missed billing the County for approx. 2,400 tons (approx \$16K) of MSW. Mr. Minor is continuing research.
- Review of DOC Trends
 - Trend lines were reviewed. HH, Bluffton, Gate + St Helena; averaging 1,000 cars per day
- Recycling
 - Diversion payments to the City of Beaufort help support and encourage recycling. Glass is the only commodity that they are taking to the MRF, costing County \$62 p/ton
 - Other Recycling Revenues Include: Charleston Steel 79,612 plus latest pickup, + S&P 13,921 + Waste Management 73,089 + \$166,630 for FY06.
 - Mr. Stewart asked about the County ordinances for recycling. They do not force a waste hauler to pick up recycling thus there is no curbside in Sun City. Recycling is required in the Sun City PUD. Mr. Minor will review EOI's for ideas.
- Capital Improvements
 - Mr. Bellamy described problems and progress at new Simmonsville DOC
 - A brief power point w/pictures was shown
 - o Landscaping will not be totally completed until Bluffton Parkway finished.
 - o The impoundment pond at Simmonsville will be renovated by PW.

- EOI Proposals
 - o 3 Companies responded: Republic, VQuip, & Waste Management
 - Pratt did not submit.
 - o Waste Management-Solution continues basically same with negotiable fees to keep doing what we are doing
 - Republic- Public private partnership including the design and building of a transfer station for MSW and C&D
 - o VQuip-Suggested reconfiguration of DOC's with their equipment at \$28.77
 - Some other vendors will apply when we develop an RFP
 - o A consultant will assist the County with construction of an RFP
 - o The EOI has improved the negotiating position w/WM
- IFB for Hazardous Waste Roundup
 - We received three Bids for this project: PCI, CARE, and EQ
 - The informational flyer has been printed and ready to be distributed
- Debris Management
 - o A major storm will change the entire budget and waste management picture
 - o Mr. Minor has been talking with a natural disaster consultant for assistance w/debris management
 - Would like "stand by" agreement with landfill area out of hurricane area to take debris because a major storm will fill up all existing landfill space
 - o Debris management strategies were discussed
- Ms. Lindsay and Ms. Murphy presented the Recycling Coordinators report for April 2006.
 - They reported on the EWaste Pickup at Chatham County with MOLAM industries noting that it was free except for monitors and TVs. They hope to schedule for fall
 - The Household Haz Mat pickup plans are underway with exceptional cooperation by Fire Depts.
 - The Rechargeable Battery recycling program has collected 3 boxes (40 lbs each) in April.
 - Ms. Lindsay is working on organizing the data base system for solid waste & recycling info
 - WEB site in process of being updated. MIS agreed to put recycle logo on home page.
 - Members received copies of new brochures for review: "A Guide to Disposal of Reusable Household Items" and Hazmat Roundup w/info on reverse
- The meeting was adjourned at 4:00 p.m.
