- Call to Order: Chairman Dietz called the meeting to order at 2:10.
- Minutes: Mr. Bowers motioned and Ms Fripp seconded and the board approved the minutes from February 08.
- Monthly Reports
  - o Mr. Minor reviewed January data commenting on the limited capacity of each DOC and that eventually higher traffic areas would have to seek curbside and other solutions to volume.
  - o Pritchardville traffic climbing daily in a center not designed for that volume.
  - o DOC recycling success is noted by current tonnage at 334 tons when 5 years ago it was less than 100 tons.

## • Litter Officers' Reports

- o Mr. Minor noted that we were in the process of replacing one of our Litter Officers and the vacancy would probably be filled by a current experienced deputy.
- o Cpl Black reported on various activities including the upcoming Zero Tolerance campaign sponsored by the SC Law Enforcement Association. Various promotional and educational activities will be presented in this campaign.

### • Recycling Coordinators Report

- \$315,000 has been collected in recycling proceeds through mid March with \$90,000 in most recent white goods collection and sale.
- Dates for Events set:
  - Electronics Event Collection: 84,000 lbs of materials were collected
  - Household Hazardous Collection
  - 3/1/2008 Bluffton; 235 cars, 70 HH residents \$15,500 cost
  - 5/3/2008 Shanklin site set
  - Festivals: 3/15-Greenfest, 4/19-Crabfestival, 5/3-Taste of Beaufort

#### Old Business

- Solid Waste Disposal Contract has been approved and signed by all parties
  - This contract reduces tipping fees at Hickory Hill from \$49.80 to \$37.75 p/ton.
  - This contract will save approx. \$300,000 in FY08 and approx. \$600-700K in FY09
- FY09 Budget was reviewed
  - Mr. Minor noted the anticipated savings through the contract and other savings from the change from charging commercial disposal back to the haulers.

#### • New Business:

- o Mr. Bellamy announced the Jim Minor, had been named Solid Waste Manager of the Year by SCDHEC.
- The Meeting adjourned at 3:35 p.m. The next meeting will be held April 17, 2008, 2:00 pm Public Works Conf. Room.
