### **Candidates and Offices**

#### Types of Offices

- Partisan
  - Must be endorsed by party to have name on the ballot, or...
  - Must file a successful petition for candidacy
- Non-partisan
  - No party endorsement necessary to get name on the ballot

#### **Types of Candidates**

- Partisan
- Non-partisan
  - Petition
  - Statement of Candidacy
  - Write-in







#### Primary vs. General Election

#### **Primary**

- Partisan contests only
- No write-ins allowed
- Runoff elections may be used to determine winner
- No concurrent elections
- Winners get on November General
   Election ballot

#### **General Election**

- Partisan and non-partisan offices and candidates
- Write-ins allowed
- No runoff elections
  - Can be combined with municipal elections and referendums
    - Winners elected to office





#### **Petitions** (format)

- Printed on good quality original bond paper sized 8.5" x 14"
- Candidate name and office sought must appear on every page
- Separate columns for:
  - Signature and printed name of voter
  - Address of voter
  - Voter's precinct

### Petitions (process)

- Must contain signatures of at least 5% of voters in district, not to exceed 10,000 signatures
  - 2.5% for Board of Education
- Official number of signatures required is set
   120 days prior to election
- By noon July 16, 2012 submit petitions to...
  - State Election Commission for multi-county offices
  - County Election Commission for countywide, or less than countywide offices, except for municipal offices

### Petitions (verification)

- Petitions requiring 500 or less signatures
  - Every signature checked for validity against voter's original application for registration
- Petitions requiring more than 500 signatures (percentage method)
  - Every one of first 500 signatures checked
  - Over 500...one out of 10 signatures checked
  - If projected number of valid signatures total minimum number required, petition is certified
  - No petition may be rejected using percentage method

#### Ethics Requirements (statements of economic interest)

- Must file Statement of Economic Interest (SEI) at same time and with same official with whom candidate files statement of intention of candidacy (SIC) or petition
  - Does not apply to a public official who has a current SEI on file (e.g., incumbents)
- SC Supreme Court ruling in *Anderson v. South Carolina Election Commission* 
  - Online filing alone is not enough

### Ethics Requirements (campaign practices)

- Process owner: SC Ethics Commission
- Initial report due w/in 10 days after spending or receiving the first \$500 of campaign funds
- Pre-Election Report must be filed no later than 15 days prior to each election, and no earlier than 20 days prior
- Quarterly Reports
  - January, April, July and October
  - Whether there is activity or not
- Final Report after campaign account closed

### Election Day (general information)

Polls open 7 am to 7 pm



- No campaign literature within 200 feet of entrance to polling location [SC Code of Laws 7-25-180(A)]
- Candidates at polling place [SC Code of Laws 7-25-180(B)]
  - Can stand outside to meet and greet voters, and may solicit votes (even within 200 ft)
  - May wear badge no larger than 4.25 x 4.25 inches with name and office sought (no logos)
  - May enter the polling place at any time, but...
    - Name badge must come off
    - Voters must not be disrupted





### Election Day (voter qualifications)

- Must be 18 years of age on or before the date of election
- Must be a U.S. citizen
- Must be South Carolina resident
- Must be resident of the precinct in which applicant is applying to vote
- Register no later than 30 days prior to election





### Election Day (voter disqualifiers)

- A voter may not be . . .
  - Mentally incompetent as adjudicated by a court of competent jurisdiction
  - Serving a prison term
  - Convicted of felony or offense(s) against election laws
    - Disqualification can be removed by service of sentence or pardon, to include all parole and probation served





### Election Day (poll watchers)

- Poll Watchers
  - Registered voter certified in writing by candidate or party
  - Certification is precinct specific
  - Wear badge no larger than 4.25 by 4.25 inches with name and entity representing
  - Staffing
    - Primary: one watcher per candidate per precinct
    - General Election: candidates of same party jointly represented by no more than 2 watchers per 1,000 registered voters at polling place







### Absentee Voting



- Two methods: 1) in-person and 2) mail
- Applications can be requested on line, or via telephone, email, fax or standard mail
- Applications can be transmitted electronically
- Voter must provide one of 17 reasons on absentee ballot application
- Ballots must be mailed (UOCAVA exception)
- NO SUCH THING AS "EARLY VOTING" IN SC

### <u>Certification of Results</u>

- Who: Board of Canvassers
- When (no later than):
  - Primary 1 pm Thursday following primary
  - General Election 1 pm Friday following election
  - Special Election 1 pm Friday following election
  - Municipal Election 3 days following election
- What:
  - Conduct provisional ballot hearing
  - Certify vote totals...from "Unofficial" to "Official"

#### **Protests**

Primary

- andov following
- Deadline for filing protest is Noon Monday following certification
- File with party, county sheriff or SLED, as applicable

#### Election

- Municipal 48 hrs post election w/ municipal election commission
- Countywide and less than
  - Noon Wednesday after certification w/ CEC Chair or Sheriff
- Multiple counties, state offices and statewide offices
  - Noon 5 days after certification w/ SC Election Commission

#### **Protests**

Protests must be in writing



- Each ground on which the protestant wishes to protest must be included
- Items not included in written protest may not be addressed in hearing
- Only candidates have standing
  - Protests filed by other parties are not accepted as an official protest
- Rules of evidence apply in hearing
