# I. JOANNE GRANT-SPECIAL USE PERMIT, LODGING, SHORT-TERM RENTAL APPLICANT JOANNE GRANT

Mrs. Grant stated to the Board that she and her husband are seeking approval for a Special Use Permit to conduct Lodging, Short-Term Rental at 167 Sea Pines Drive.

Ms. Austin stated that the Board will make the decision about the approval of the Special Use, but she would like to add a condition to the approval, that allows Staff to withhold the Zoning Permit until the clearing of the freshwater wetlands, the buffer and setback is replanted. She stated that it came to her attention that morning that the Grant's brought in dirt and cleared all the vegetation from the wetland and the setback/buffer. She stated that a revegetation plan must be submitted for review by the Natural Resources Planner and the area planted prior to the zoning permit being issued.

Mr. Grant stated that he did not clear the wetland and he did not place dirt in the wetland, he only went in and cleaned out the debris. He also stated that they are willing to replant and would like to not have the approved delayed.

Mrs. Cathy Huston stated that she agrees with the Short-Term Rental.

Mrs. Dianne Replogle stated that she agrees with the Short-Term Rental.

Mr. Mack closed **PUBLIC COMMENT**.
